Illegal landfill in Kidlington

There has been much news coverage of the enormous fly tip alongside the A34 and River Cherwell in Kidlington. The tip is 6m high and 150m long and comprises chopped waste mixed with soil. Callum Miller has estimated that the cost as to be more than the annual budget of Cherwell District Council. A local fisherman first reported the incident to the Environment agency in September who said, "The Environment Agency will try to "ensure those responsible" for the waste cleared it up." Until responsibility is resolved it unlikely that the tip will be removed but that will not reduce the risk of a pollution incident in the River Cherwell. Planning training and support for Town and Parish Councils approved

I'm delighted that my motion has been agreed and that Cherwell District Council will assist Town and Parish councils in the planning process. I also hope that we can find ways to ensure that infrastructure is kept within the communities taking the housing and I'll continue to push for the maximum increase in Primary Care services.

Planning

Whilst the planning committee meeting was quite quiet, that's not the case across the district. Work continues on the major developments and another site in the NW Bicester Development masterplan has come forward for 400 homes.

Local Government Reorganisation

The three plans have been considered and will be submitted to the Government shortly. Work at Cherwell now turns to Devolution and preparation for a mayor. Oxfordshire County Council will be leading on this as the lead authority but CDC still have a role to play. The expression of interest will be submitted to the Government before Christmas.

Transformation Program

Cherwell District Council's transformation program is a multifaceted initiative focused on improving services and operations, with key projects including a significant IT and data transformation to a cloud-based infrastructure and the development of a new "Cherwell Futures" program.

This includes partnerships with City of Oxford Council and West Oxfordshire District Council on waste collection services and a review of other council functions.

While there are some positive proposed capital investments, including kerbside glass collection and support for temporary housing.
